**LISBON STRATEGY: “COMMIT AND DELIVER” BUSINESS LEADERS TELL HEADS OF STATE AHEAD OF THE SPRING SUMMIT**

Ahead of the upcoming Spring Summit, EuroCommerce, UEAPME, UNICE and EUROCHAMBRES have expressed their dismay at the horrific attacks in Madrid and extend their deepest sympathy to all the victims and families. The European business organisations strongly support the intention of EU Heads of State to reinforce measures to combat all forms of terrorism in Europe.

Implementation of the Lisbon Strategy and the future EU Constitution are the two other key issues on which the European Council must deliver, first of all at the Summit and then back home. Almost halfway along the time path for the Lisbon strategy, Europe is still nowhere close to reaching the objective of becoming the most competitive and dynamic knowledge-based economy in the world by 2010. The EU will not reach the Lisbon objectives unless EU countries make significant progress in implementing national reforms.

Urgent action at both national and EU level is required: EuroCommerce, UEAPME, UNICE and EUROCHAMBRES call on Member States to:

- Reduce existing regulation while aiming at better regulation, with a compulsory business impact assessment for new legislative proposals
- Engage in thorough reforms of social protection systems and decrease structural government deficits in view of meeting the challenge of an ageing population and ensuring fiscal sustainability
- Stimulate R&D and innovation in cooperation with business and knowledge institutions and improve the general, fiscal and financial conditions for innovative investment
- Promote entrepreneurship by lowering the tax level for companies
- Develop strategies and concrete action plans on entrepreneurship for all sectors and introduce the teaching of entrepreneurial skills in schools. Promote lifelong learning systems to satisfy companies' needs and to upgrade employees' competences
- Accelerate reform of national labour market regulations to introduce more flexibility and productivity at work, the ultimate goal being to create more and better jobs by 2010. Special focus has to be placed on the follow-up to the recommendations of the Employment Task Force
- Close the gap in implementing the internal market in order to boost efficiency.

At the EU level, both the European Commission and the (Competitiveness) Council must organise themselves better to make sure that regulations are thoroughly evaluated against the need for competitiveness.

Finally, EuroCommerce, UEAPME, UNICE and EUROCHAMBRES urge the Summit to work towards reaching an agreement on the EU Constitution in order to provide Europeans with an institutional framework which will allow an enlarged Europe to function effectively.
