Our Associations particularly appreciate the high level of cooperation and interest shown by the Offices, and especially the willingness to listen to and consider the input and desires of industry in creating the Global Dossier.

Our Associations consider the Global Dossier to be one of the highest priorities in the discussions within IP5, and we have made our input to the Global Dossier project a high priority within each of our Associations.

In order to maintain the momentum generated by the very successful Task Force meeting in The Hague, we encourage each of your Offices to provide the resources needed to move the Global Dossier forward as quickly as possible, while maintaining the basic principles that the Offices and the Associations have been using as a basis of their discussions. While we understand there may be practical limitations based on IT and budgetary cycles, we strongly encourage your Offices to provide for the quickest implementation possible, without deviating significantly from the basic principles of the Global Dossier.

The participating Associations in The Hague drafted a statement of vision or principle concerning the definition of "What is the Global Dossier," from the point of view of industry. We were extremely gratified to hear from our representatives that all of the Offices, while acknowledging this statement was made from the point of view of industry, indicated that their conception of the Global Dossier did not differ significantly from this statement.

We are now pleased to send you a formal version of the statement that has been approved by all of the industry Associations signing this letter. We hope this statement of principles will be helpful to the IP5 Offices in going forward with discussions on the Global Dossier, among themselves, and with industry.



## **GLOBAL DOSSIER**

**The Global Dossier will constitute a set of business services, including an integrated on-line web portal/user interface, allowing two-way communication between users and all participating offices, singly or in multiples, with “passive” (database) and “active” (filing, prosecution and management) components. It will allow users to efficiently access all available information about all applications and patents in the participating offices, and to utilize the electronic services of the offices.**

**The Global Dossier will be accessible by applicants/patent owners and their representatives, examiners and other Office officials, interested third parties, and the public at large, while limiting access of confidential information to authorized persons. It will enable communication and collaboration between applicants and examiners, and among examiners in different offices, thereby facilitating the possibility of increased quality, work sharing and acceleration of examination. Machine translation will be an essential part of Global Dossier.**

**The Global Dossier is intended to enable and encourage streamlining and improvement of office procedures, including cross-communication and harmonization of procedures among the participating offices, in order to provide the most efficient and cost-effective user environment possible, especially for applications filed in multiple offices.**
