- BUSINESSEUROPE and BUSINESSMED have closely worked together in the past on various joint declarations to promote trade and investment between the EU and the Southern Mediterranean.
- In addition BUSINESSEUROPE's social department has been in contact with BUSINESSMED and its members to discuss issues related to youth employment, education and social dialogue.
- BUSINESSEUROPE has always encouraged a strong grouping of the various employer federations in the Southern Mediterranean to allow you to speak in one voice and present a united front.
- We are happy to see that BUSINESSMED has come out stronger following the democratic changes in many of your countries and is active and engaged on the pressing economic issues in the region.

- BUSINESSEUROPE has good experiences organising important events in the BOSMIP projects in the Western Balkans and Turkey to transfer know-how and expertise on EU regulations and related business issues.
- This will be increasingly important for the Southern Mediterranean as the European Commission is planning to negotiate deep and comprehensive free trade agreements which will incorporate aspects of EU legislation.
- We look forward to working with you on these issues.
